## **Close cooperation with the government to overcome COVID-19**





#### Cooperation with the government to overcome COVID-19

As of July 2022, we have agreed to cooperate closely with the government to effectively overcome the resurgence of COVID-19 in the second half of the year, and made a joint announcement between the Korean Medical Association and the Korean Disease Control and Prevention Agency.







#### Cooperation with the government to overcome COVID-19

In order to overcome the resurgence of the pandemic early on, the Korean Medical Association and the Korean Disease Control and Prevention Agency agreed to build a flexible cooperation system through

- Apreparations for one-stop diagnosis and treatment centering on local clinics and hospitals
- ▲ support for medical institute infection control and safe treatment environments to ensure safe examination and treatment ▲ establishment of a round-the-clock communication channel that reflects the opinions of experts and medical in policies, etc.





Strong request to the government to withdraw the change of the English naming of oriental medical doctors (Doctor of Korean Medicine) due to concerns of confusing citizens





#### **Oriental medical doctor -> Doctor of Korean Medicine**

Despite many disputes, the Ministry of Health and Welfare Approved changing the English naming of 'Oriental Medical Doctor' to 'Doctor of Korean Medicine' on July 26, 2022, to which the Korean Medical Association strongly requested the government to withdraw the changing of the English naming of oriental medical doctor to doctor of Korean medicine.

In Korea, oriental medicine are clearly distinguished according to the Medical Service Act to operate different licensing systems, and the area of work of doctors and oriental medical doctors are clearly Differentiated.





#### **Oriental medical doctor -> Dortor of Korean Medicine**

Accurate English naming is necessary so that citizens using medical services can clearly know whether the medical service they desire is 'medical science' or 'oriental medicine,' thus preventing confusion and allowing them to safely select between medical doctors and oriental medical doctors.

#### **Blocking the Nursing Legislation**

The Korean Medical Association organized an emergency planning committee to block the Korean nursing legislation and held one-person relay demonstrations in front of the National Assembly and national rallies to block the nursing legislation. In April, the President of the WMA (World Medical Association) expressed support for the position of the Korean Medical Association related to the nursing legislation that was motioned for in the Korean National Assembly.





#### **Blocking the Nursing Legislation**

Main contents: It was strongly expressed that the nursing legislation motioned for by the Korean National Assembly may not ensure the best and most appropriate medical treatment for patients, and having nurses provide essential medical treatment without supervision of a doctor or having a nurse's aide provide medical treatment under the supervision of a nurse are in violation of the 'best treatment rule' for medicine, and that this may potentially damage and dismantle existing team-based medical services.

#### **Reinforcing self-regulation by doctor**

By installing a self-regulation report center, we have established a round-the-lock reporting system that is being operated with the 3 main rules of ▲strict and firm self-regulation ▲organized and systematic self-regulation, and ▲joint self-regulation by the central and municipal and provincial medical associations.

Furthermore, the medical license program will be managed systematically and efficiently through an independent license management organization, and the Korean Medical Association will enhance ethics and expertise of doctors through self-regulations of medical licenses, thereby solidifying the status of medical experts, and moreover, take the lead for protecting the health and lives of citizens.
